STJCC Terms and Conditions for Member Participation

Thank you for your cooperation

1. ALL Members must check in to the Golf Shop prior to playing the golf course. Member tee times may be made up to 14 days in advance. Social Club Members 10 Days in Advance. STJCC reserves the right to make alternative tee time considerations for tournaments, special events and out-of-town guests. If a Member makes a tee-time, they are responsible for notifying the pro shop 24 hours ahead of time in the event that they have to cancel, or will have less players then originally booked. We ask that members give us the courtesy of respecting the tee sheet and insure that we have the opportunity to sell any time that they will not be using.

2. Except as expressly provided herein, payments and fees for participation in the Membership are non-refundable.

3. Our tee times are valuable inventory. If you are not going to use your tee time or will have less players then reserved, Members must notify the Pro Shop, so that these openings can be made available to another member or guest. If a member consistently fails to call the Pro Shop to cancel a tee time after we have reminded him of this policy a repetitive "no show or late cancellation " fee of \$10 per incident will be charged. These Fees are not applicable if course is deemed unplayable or in instance of severely inclement weather conditions.

4. It is the player's responsibility to be informed of and knowledgeable of the rules and regulations of the club.

5. STJCC reserves the right to host tournaments/outings which are not open to the public or Members. STJCC reserves the right to close any and all areas of the golf course as it deems necessary.

6. Use of the Golf Course and Practice Complex shall be at Member's risk and responsibility, and Member agrees to hold STJCC harmless from any claims, losses, or damages sustained by Member in the course of its participation or activities on the Golf Course or at the Practice Complex. Each member as a condition of membership and each guest a condition of invitation to the Club facilities assume sole responsibility for his or her property. In the event Member shall directly or indirectly cause damage or loss to STJCC, including its facilities and properties, through negligence or by intentional misconduct, Member shall be liable to STJCC for any such costs and damages, as well as any legal fees that may be incurred by STJCC.

7. Member agrees to abide by all STJCC rules, regulations, policies and procedures. STJCC reserves the right to implement and enforce all operational policies, i.e. dress code, personal conduct, staffing, capital improvements, conditions of course/practice areas, and proper etiquette. Members and guests must follow and adhere to all rules and regulations set forth by STJCC. Any rules violations may result in suspension or revocation of membership. Should a member be suspended or membership privileges be revoked, there will be no prorating or refund of dues paid. STJCC reserves the right to revoke membership privileges for misconduct and failure to follow club rules and regulations and failure to respect the facility, our employees and our guests.

8. Golf Cart rules will be established on a day-to-day basis. Golf Carts must stay on cart paths around all tees and greens and park with all four wheels on the cart path. Members must observe all cart rules, signs and roped areas. Failure to do so may result in a warning or suspension of playing privileges If the group in front of you is not obeying cart rules, please notify the Pro Shop.

9. No more than four players may play as a group unless specific authorization is granted from the Pro Shop Staff.

10. No more than 2 golf carts per foursome & 1 golf cart per twosome allowed. Each player must have a set of clubs.

11. Faster players must be allowed to play through if there is a clear hole open ahead of your group.

12. Do Not park on Turf around tee & green complexes or bunkers. Please repair ball marks, replace divots & rake bunkers.

bunkers. 13. The Guest of Member rate may be modified or applied at clubs discretion. It does not apply to large groups or tournament.

14. It is the player's responsibility to be informed of and knowledgeable of the rules and regulations of the club.

15. It is the member's responsibility to make sure that all guests in their group have paid their greens fees.

By signing below, Member agrees to all the terms stated below and further agrees that any outstanding payments, fees or charges owing to STJCC by the Member shall be charged to the credit card above without any further notice. And, by signing below I hereby acknowledge that participation or use of STJCC has inherent risks of injury, and I fully accept any and all risk of injury to myself or my guests sustained while using any of the facilities. In accepting the risk of injury I understand that I am relieving Firinn Golf Group of VT, LLP its managers, partners and employees and affiliates of liability.
